Overview of the Joint GMI/CCAC Steering Committees Meeting Discussion Paper

I. Purpose

This paper provides an overview of the joint Global Methane Initiative (GMI) and Climate and Clean Air Coalition (CCAC) Steering Committees meeting on Tuesday, 29 March 2016.

II. Background

In an effort to promote closer collaboration with CCAC and to provide an opportunity to meet our CCAC counterparts in person, CCAC Steering Committee members will join the GMI Steering Committee delegates for the last hour (5:00 – 6:00 p.m.) of the GMI Steering Committee meeting on Tuesday afternoon. The following countries/organizations are members of the CCAC Steering Committee (countries with dual GMI membership in **bold**): **Canada** (interim co-chair), **Chile** (co-chair), Cote d'Ivoire, Institute for Advanced Sustainability Studies (IASS), Institute for Governance & Sustainable Development (IGSD), Inter-American Development Bank (IDB), International Centre for Integrated Mountain Development (ICIMOD), Kenya, Netherlands, **Norway**, **Philippines**, and the **United States**. A complete list of the current GMI Steering Committee members and CCAC Steering Committee members are provided in Tables A and B, respectively.

III. Purpose/Structure of this Meeting

This joint meeting will allow an opportunity for GMI and CCAC Steering Committee members to learn about each other's initiative (e.g., organization, activities) and engage in an informal discussion to enable potential future collaboration on similar work streams and on cross-cutting issues (e.g., regional assessments, action plans, NDCs). The ASG is currently working with CCAC to develop an agenda for the joint session. Preliminary topics include:

- Formal introductions
- Overview of GMI and CCAC from joint co-chairs¹
- Discussion of potential future collaboration
- Discussion of potential future coordinated in-person meetings

The joint meeting will be co-chaired by both GMI and CCAC (Janet McCabe, U.S. Environmental Protection Agency and GMI Steering Committee Chair, and Rita Cerutti, Environment Canada and CCAC Interim Co-Chair, respectively), who will sit at the head table. Remaining GMI and CCAC Steering Committee delegates will be seated around the table in alphabetical order by country.
