Participation

- 18 of 21 Partner countries were represented
- Steering Committee welcomes the European Commission as its newest member
- Steering Committee plans to meet again in Oct/Nov 2008
 - Subcommittees should meet once in first half of 2008
 - 2nd 2008 meeting to be held in conjunction with the Steering Committee meeting



Subcommittee Reports

Agriculture

- Expand to include agri-food waste and slaughterhouse waste
- Subcommittee to evaluate potential for M2M role in addressing methane mitigation from other agriculture sources (enteric fermentation, rice, biomass)

Coal

Country specific strategies

Landfill

- Added Ecuador as vice-chair of Landfill Subcommittee
- Necessary to maintain up-to-date roster of active Subcommittee delegates

Oil and Gas

- Importance of national government involvement in recruiting oil and gas company participation
- Need to make CH4 reduction a priority



Steering Committee Decisions: M2M Expo

- A great success!
- ASG and Expo Taskforce to develop assessment of current Expo including feedback from private sector attendees
- Tracking project outcomes after meeting
- Steering committee decision to initiate plans for another Expo in next few months
 - Another Expo Taskforce...



Steering Committee Decisions: Project Network

- Continue outreach efforts to recruit new PN members and encourage stronger PN participation
- Provide for ways to increase attractiveness of active participation in Project Network
 - ASG and Subcommittees to develop PN member/project recognition criteria
- ASG to provide Partners with quarterly updates of new Project Network members
- Need to conduct periodic review of existing PN partners (e.g. updating contact information)



Steering Committee Decisions: Outreach and Communication

- Continue efforts currently under way
 - M2M Website
 - Methane International Newsletter
- Improve press coverage of M2M related activities
- Countries to consider developing materials in their native language to increase dissemination of information to non-English speaking audiences
 - ASG can work with countries to provide links to websites etc...
- Continue to have M2M presence at major conferences (e.g. CSD, COP etc...)



Steering Committee Decisions: M2M Report and Opportunities Paper

- M2M Accomplishments report
 - ASG to develop annotated outline (clarify purpose and include suggestions for length)
 - Timing to be determined (2008 or 2009)
- Methane Opportunities Analysis
 - As an outcome of the 2006 SC meeting the ASG prepared a review of available information on methane mitigation opportunities
 - Steering committee provided input; ASG to incorporate and revise as outreach piece
 - Partners can submit additional ideas and input for next steps for discussion at 2008 steering committee meeting

Charge to Subcommittees: Project Network Recruitment

- Continue outreach efforts to recruit new PN members and encourage stronger PN participation.
- In coordination with ASG, develop recommendations to provide ways to increase attractiveness of active participation from PN members and to recognize specific projects (e.g., recognition awards, publicity)
 - Recommendations to be reviewed at 2008
 Steering Committee.



Charge to Subcommittees: Communications and Outreach (1)

- Web Site: Work with the ASG to enhance the Web site and provide information resources relevant to the sector and the activities of the Partnership.
- Newsletter: Provide input to the M2M newsletter to highlight projects, conferences, or other success stories.

Communications and Outreach (2)

- M2M Project Tracking System:
 Subcommittees should utilize the newly revised system to facilitate greater information sharing on projects and activities.
- Publicizing the Partnership: Subcommittees should undertake outreach activities and provide links to press releases or other new items to the ASG for inclusion on the Methane to Markets Web site.



Charge to Subcommittees: 2008 Future Meetings

- Subcommittees should meet once in the 1st half of 2008
- ASG will work to organize a combined meeting with Steering Committee Oct/Nov 2008
 - Similar to meeting in Buenos Aires
 - ASG to follow up with possible host countries
